# 4.1 Chairman's Report

Unwanted taxidermy item recently sold at auction in aid of village hall funds (committee had agreed it had no place in the village hall ).

Grant funding received for kitchen refurbishment which needs to be spent before the end of the summer or will have to be given back potentially. Meeting scheduled with builder to try to agree timescale for works.

2 old tables have now been refurbished and are back in use

Future hiring charges - due for review in March. Chair suggested a comparison study of what other local Village Halls are charging would be useful to feed into this review. Karin and Brian agreed to look at 5 similar Village Halls.

# 4.2 Treasurer's Report

A quiet time over Christmas. A little income received but a couple of large expenses – Aldens (Electrical work) and Robert Cliffe (gas service and urinal fix) resulted in costs of over £1,600 being incurred. These have contributed to the currently deficit of £3,532 from ordinary activities. (not including the funds raised and grants received for the restoration fund.) Preschool have paid their invoices up to date, but payment from Scouts is are still awaited.

# 4.3 Restoration Fund

Phase 2 fundraising is continuing with applications being submitted to the Asda community Fund and the David Ross Charitable Foundation.

A new appeal letter has been drafted and will sent for print shortly. Distribution round the village will need to be organised.

A donation has been received from the Village Wine Safari held in November. The committee wished to record their thanks to Caroline Jack.
